"That the institution shall take appropriate measures for prevention of ragging any form, in the light of direction of Supreme Court of India in Writ Petition No. (C) 656/1998. Incase of failure to prevent the instances of ragging by the institutions, the council shall take appropriate action including withdrawal of approval."

"That the institution shall provide the facilities for the physically challenged persons viz: Barrier free entry, class room, toilets and hostel to be made accessible, resource room for visually impaired, accessible

library, counseling center, facility of sign language interpreter.

The additional intake is being granted based on the projection shown in the Detailed Project Report regarding additional built-up space, faculty and other facilities for the proposed intake. It may be noted that all facilities including additional built up area should be made available before the commencement of the next academic session. Random surprise inspection would be carried out to verify facilities and if the institute is found deficient in fulfillment of norms & standards of AICTE, the Council would initiate appropriate action. Please note that others terms & conditions mentioned in the earlier letter will remain.

This approval is granted based on the Appraisal of the information by the Institution on infrastructural faculty and academic facilities created for the proposed course(s). Therefore the institution through an Expert Committee visit subject to the verification of the claims makes the approval. In case the claims made by the institution are found to be false, the approval granted shall be liable to be withdrawn.

Note: -* The Approval is valid for two years from the date of issue of this letter for obtaining affiliation with concerned university and fulfilling concerned State government requirement for admission.

The Jaipurla Institute of Management Studies, Sector-14C, Vasundiana, Ghazlabad(UP) shall obtain necessary affiliation/ permission from the concerned affiliating University as per the prescribed schedule of the University/ Admission Authority etc. The Applicant Society/Trust/institution shall send information about commencement of the above courses to AICTE. In case the Institution could not commence the above mentioned courses for whatsoever reasons during the two years period from the date of issue of this letter, the approval becomes invalid and the applicant society/trust shall have to make fresh application to AICTE for grant of fresh approval.

The approval is further subject to fulfillment of following conditions.

- That the management shall provide adequate funds for development of land and building and for providing related infrastructural, instructional and other facilities as per Council's norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
- 2. (a) That the admissions shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.
 - (b) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.
 - (c) That the admissions to the courses shall be made only after the affiliating University /State Board has given permission to start the course.
 - (d) That the Institution shall not allow closure of the Institution or dis antinuation of the course(s) or start any new course (s) or after intake capacity of seats without the prior approval of the Council.

- (e) That no excess admissions shall be made by the Institution over ϵ_1 d above the approved intake under any discumstances.
- (f) That the institutions shall not have any collaborative arrangements with any Indian and/or Foreign Universities for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE.
- (g) That the Institution shall not allow conduct of any unapproved course whether technical or non technical in the premises of AICTE approved institution/campus and /or in the name of the Institution without prior permission from AICTE.
- 3. That the institution shall operate only from the approved location, and that the institution shall not open any off campus study centers/ extension centers directly or an collaboration with any other institution/ university/ organization for the purpose of imparting technical education without obtaining prior approval from the AICTE.
- 4. That the tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students/guardians of students in any form.
- 5. That the accounts of the Institution shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the Council or any body or person authorized by it.
 - That the Director/Principal and the teaching and other staff small be selected according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales are paid as per the norms prescribed by the Council for time to time.
- 7. (a) That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper maintenance of administrative and academic standards.
 - (b) That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses/programmes being conducted and details of infrastructural facilities including faculty etc. In the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on cost basis. The mandatory disclosure information shall be housed in the institution Web-Site. The Information shall be revised every year with updated information about all aspects of the institution.
 - (c) That it shall be mandatory for the technical institution to maintain a web-site providing the prescribed information. The website information must be confinuously updated as and when changes take place.
 - (d) That a compliance report in the prescribed format along with mandatory disclosure on fulfillment of the above conditions, shall be submitted each year by the Institution within the time limit prescribed by the Council from time to time.
 - (e) That if Technical Institution falls to disclose the information or suppress and/or misrepresent the information, appropriate action could be initiated including withdrawal of AICTE approval.
- 8. That all the laboratories, workshops etc. shall be equipped as por the syllabil of the concerned affiliating University and shall be in operational condition before making admissions.
- That a library shall be established with adequate number of titles, books, journals (both Indian & Foreign) etc as per AICTE norms.
- That a computer center with adequate number of terminals, Printers, legal software etc. shall be established as per ACCIE norms.
- 11. That a Refundable Performance Guarantee Fee (RPGF) shall be dept-sted with AICTE, New Delhi for an amount and period prescribed by the Council from time to ting.
- 12. AICHE may carry out random inspections round the year any time for recifying the status of the Institutions to ensure maintenance of norms and standards.

- 13. That the AICTE may also conduct inspections with or without notifying the dates to verify specific complaints of mis representation, violation of norms and standards, mis-practices etc.
- 14. That the Institution by virtue of the approval given by Council shall not automatically become claimant to any grant-in-aid from the Central or State Government.
- 15. That the Management shall strictly follow further conditions as may be specified by the Council from time to time.
- 16. That the institution shall take appropriate measures for prevention of ragging in any form, in the light of directions of Supreme Court of India in Writ Petition No. (C) 666/1998. In case of failure to prevent the instances of ragging by the institutions, the Council shall take appropriate action including withdrawal of approval.
- 17. That in the event of a student / candidate withdrawing before the starting of the course, the walt listed candidates should be given admission against the vacant seat. The entire fee collected from the student, after a deduction of the processing fee of not more than Rs. 1000/- (Rupees one thousand only) shall be refunded and returned by the Institution / University to the student/candidate withdrawing from the programme. It would not be permissible for Institutions and Universities to retain the School/Institution Leaving Certificates in original to force retention of admitted students (See Public Notice AICTE/DPG/03(01)/2008).
- In the event of non-compliance by the Jalpuria Institute of Management Studies, Sector-14C, Vasuadisara, Giaziabad(UP) with regard to guidelines, norms and conditions prescribed from time to time the Council shall be free to take measures for withdrawal of its approval or recognition, without consideration of any related issues and that all liabilities arising out of such withdrawal would solely be that of the Jalpuria Institute of Management Studies, Sector-14C, Vasuadisara, Ghazlabad(UP).
